| Medical Questionnaire | Your child will be unable to register on the first day of term without a completed medical questionnaire. You can access the form via the 'Reply' button on the email. | Monday 27 July | |
| Music lessons | All D parents are required to book music lessons for their child. Parents may also book music lessons for pupils starting at Bryanston in C or A3. You do this by completing the form via the link in the email. | Monday 3 August | |
| Outdoor Education Consent Form | In the junior years, outdoor education is a compulsory part of the timetable at Bryanston, so it is important that you complete a consent form for each pupil entering the school in years D or C.
